APPLICATION FOR ADMISSION TO VARIOUS PROGRAMMES FOR 2008/2009 ACADEMIC YEAR

The Moshi University College is hereby inviting qualified individuals to apply for the following programmes that will be offered during the 2008/2009 academic year:-

1.0 POSTGRADUATE DIPLOMA PROGRAMMES

1.1 Fulltime Postgraduate Programmes

These are one-year programmes (two semesters) designed for both pre-service and in-service personnel.

- i) Postgraduate Diploma in Cooperative Business Management (PGD-CBM)
- ii) Postgraduate Diploma in Accounting and Finance(PGD-AF)
- iii) Postgraduate Diploma in Community Development (PGD-CD)
- iv) Postgraduate Diploma in Savings and Credit Cooperative Societies Management (PGD-SACCOS MGT)

1.2 Evening Postgraduate Programmes

These are one and a half years programmes designed for both pre-service and in-service personnel and are offered at Moshi campus only.

- i) Postgraduate Diploma in Cooperative Business Management (PGD-CBM)
- ii) Postgraduate Diploma in Accounting and Finance(PGD-AF)
- iii) Postgraduate Diploma in Community Development (PGD-CD)
- iv) Postgraduate Diploma in Savings and Credit Cooperative Societies Management (PGD-SACCOS MGT)

1.3 Distance Learning Postgraduate Programme

This is a one and a half year programme offered through distance learning.

- i) Postgraduate Diploma in Savings and Credit Cooperative Societies Management (PGD-SACCOS MGT)

Admission Requirements for the Postgraduate Diploma Programmes

- i) Holders of an Advanced Diploma from the former Cooperative College Moshi or MUCCoBS or any other recognized institution of higher learning.
- ii) Holders of a Bachelors degree from MUCCoBS or any other recognized institution of higher learning.
- iii) Holders of relevant professional qualifications.

2.0 DEGREE PROGRAMMES

2.1 Degree Programmes Offered

These are three-year programmes (six semesters) designed for both pre-service and in-service personnel.

- (i) Bachelor of Arts in Community Economic Development (BA-CED)
- (ii) Bachelor of Arts in Accounting and Finance (BA-AF)
- (iii) Bachelor of Arts in Cooperative Management and Accounting (BA-CMA)
- (iv) Bachelor of Arts in Procurement and Supply Management (BA-PSM)

2.2 Admission Requirements for BA-CED

(a) *Direct admission requirements*

- (i) At least three credit passes of relevant subjects at "O" Level.
- (ii) At least two Principal Passes at 'A' Level in English Language, Economics, Mathematics, Commerce, Geography and History. Consideration may also be taken for principal passes in Kiswahili, Physics, Chemistry and Biology, provided **the sum of the points should not be less than 4.0**. Points are counted as: A=5; B=4; C=3; D =2; E=1; S=0.5 & F=0.)

(b) *Equivalent qualifications*

- (i) Holders of Diploma with at least a pass grade in Cooperative Management and Accounting, Rural Development Planning, Community Development, Urban and Regional Development Planning or equivalent qualifications from recognized institutions provided they have three credit passes in relevant courses in their "O" Level certificate of Secondary education. OR
- (ii) Holders of Diploma with at least a pass grade in Cooperative Management and Accounting, Rural Development Planning, Community Development or equivalent qualifications from recognized institutions provided they have at least one principal pass at advanced level.

2.3 Admission Requirements for BA-AF, BA-CMA and BA-PSM

(a) *Direct admission requirements*

- (i) At least three credit passes of relevant subjects at "O" Level.
- (ii) Form VI with at least TWO Principal Passes at 'A' Level in, Economics, Accountancy, Mathematics, Commerce, Physics and History/Biology/ Chemistry/ Geography provided **The sum of the points should not be less than 4.5**. (Where A=5; B=4; C=3; D =2; E=1; S=0.5 & F=0.)

(b) *Equivalent qualifications*

Holders of Diploma in Cooperative Management and Accounting from the former Moshi Cooperative College and from MUCCoBS or its equivalent will be eligible, provided they have FOUR credit passes in relevant courses in their "O" Level certificate of Secondary Education or equivalent.

3. DIPLOMA PROGRAMME

DIPLOMA IN COOPERATIVE MANAGEMENT AND ACCOUNTING (DCMA)

This is a two year programme (four semesters) designed for both pre-service and in-service personnel.

Admission Requirements

(a) Direct Admission

Form VI leavers with at least one principal pass and one subsidiary in any of the following subjects: Economics, Accountancy, Mathematics, Commerce, Physics, and History/Biology/ Chemistry/ Geography. The sum of points should not be less than 2.

(b) Equivalent Admission Qualifications

Holders of relevant certificate qualifications from the former Moshi Cooperative College and MUCCoBS or any other recognized academic institutions or Examination Boards.

4.0 CERTIFICATE PROGRAMMES

These are one academic year (two semesters) programmes designed for both pre-service and in-service candidates.

- i) Certificate in Management and Accounting (CMA)
- ii) Certificate in Micro-Finance Management (CMF)
- iii) Certificate in Accounting and Finance (CAF)
- iv) Certificate in Information Technology (CIT)**

Admission Requirements for the above Certificate Programmes:

(a) Direct Admission Requirements

Form IV certificate holders with four passes in Mathematics, Bookkeeping, Commerce, Physics, Geography, Chemistry, History, Biology.

(b) Equivalent Admission Qualifications

- Form IV Certificate holders with ATEC I
- Form IV Certificate holders with NABE stage I to II
- Form IV Certificate holders with Pre-foundation Certificate of the National Board for Materials Management (NBMM) OR
- Any other equivalent qualifications from a recognized Institution.

Mode of Application:

Application to all programmes must be accompanied by:-

- (i) A non-refundable fee of twenty thousand Tanzanian shillings (Tshs. 20,000/=) for Tanzanian nationals or thirty US dollars (30 US Dollars) for Foreigners payable to Moshi University College of Cooperative and Business Studies.
- (ii) Certified photocopies of relevant academic certificates/transcripts/ result slips.
- (iii) A candidate who had previously been discontinued from any University in the last three years on academic grounds should not apply.
